ACTION TO BE CONSIDERED OR DESIRED OUTCOME

OVERVIEW

All liquor licenses expire as of December 31st and need to be approved for the calendar year of 2025. There was one licensee posted on the Tax Delinquencies – Liquor, Wine and Beer Sales list at the time the City Council approved the final round of licenses for renewals on Monday, December 16th, 2024. Michalandia Bar & Centro Botanero, LLC, were notified several times that the City is not able to renew liquor licenses that appear on the tax delinquency list.

The licensee was able to clear their business from the Tax Delinquency list on Thursday, December 19th. A copy of the MN Department of Revenue Tax Delinquency List has been attached. Prior to removal from the Tax Delinquency List, all the necessary paperwork had been provided to the City for the renewal, including payment in full for the license.

The license holders have been notified attendance at the Special Meeting is mandatory for Council approval in order to answer any questions related to the late approval of this license. In addition, the licensee has been notified that even if the Council approves the issuance of the liquor license, the timeline to get this submitted to the State of Minnesota is very tight and due to the holidays and there is no guarantee the Department of Alcohol and Gambling Enforcement (AGE) will get this license renewed by the expiration date of 12:00 AM on 1/1//2025. If they do not receive notification, by checking the AGE website to make sure their license has been approved, they run the risk of operating without a liquor license.

There have been no other issues with the license holder, their application or any concerns from the Police Department or other City Departments which would prevent approval of this license renewal outside the issues with unpaid taxes. The staff is recommending approval of Resolution 2024-158, renewing the liquor license for Michlandia Bar & Centro Botanero.
