ACTION TO BE CONSIDERED OR DESIRED OUTCOME

Approval of Resolution 2025-105, Off-Site Gambling Application by SSP Lions.

OVERVIEW

The South St. Paul Lions Club is licensed by the State to sell pull-tabs. Minnesota Statutes 349.165, Subd. 5 allows a licensed organization to conduct lawful gambling on premises other than the organization's permitted premises for 12 events per calendar year, not to exceed three days per event.

The South St. Paul Lions Club is requesting approval to conduct a raffle at the On the Road Again event, scheduled for October 4, 2025, in South St. Paul.

The application to Conduct Off-Site Gambling form has been reviewed and staff recommends approval of Resolution No. 2025-105.
